outbreak. Most outbreaks are associated with only one establishment; however, some are associated with multiple establishments. We estimate that a maximum average of 4 manager interviews will be conducted per outbreak. Each interview will take about 20 minutes. The total estimated annual burden is 4,667 hours (see Table). There is no cost to the respondents other than their time.
