Up to \$426,543 will be awarded to Staywell Health Care, Inc., in FY 2017, pending the availability of appropriated funds. Not issuing this award would result in the disruption of comprehensive HIV primary care and support services for low income, underinsured, and uninsured people living with HIV in the service area.
